Deficiency No. I remark:

Remarks conveyed by MARB to the College:

Hospital running under the name of Yugandhar multispecialty Hospital, No name board is seen for Homoeopathic Hospital.

Submission of College to Commission at appeal stage:

Our Yugandhar Multispecialty Hospital is officially registered under Section 5 of the Bombay Nursing Home. Registration Act 1949 and is a teaching homoeopathic hospital attached to Mahila Homoeopathic Medical College & Dr. Vilas Harpale PG Homoeopathic Institute Solapur, As per MSR 2013 and prevailing regulations under NCH Act 2020 and fulfils all the statutory requirements of state of Maharashtra as well as the local authority i.e. Solapur Municipal Corporation, Solapur.

Observation of Commission:

It is observed that Yugandhar Multispecialty Hospital is a constituent hospital of their trust along with Homoeopathic hospital in the same premises. However, separate hospital beds are allocated for both types of treatments.

Deficiency No. II remark:

Remarks conveyed by MARB to the College:

At the time of visitation on 28/8/2023 at 10:45am, OPD register shows entry of 39 patients, while asking about case paper of 39 patients to registration clerk, she told it

Submission of College to Commission at appeal stage:

28.08.2023 Time-10.45 am.

a) Genuine presence of patients.

b) At the time of visitation on 28/8/2023 at 10:45am, OPD register shows entry of 39 patients which are already examined in OPD's and dispensed their medicine. More than 35 patients was sitting for registration in waiting area. As per demand of Inspector who was available virtually, we had presented case paper of 39 patients to the inspection committee. They had keenly examined all case papers and satisfied but unfortunately virtual inspector is unaware of this.

Observation of Commission:

The submitted document shows 280 patients registered on 28.08.2023 and the OPD case sheets are correlating with the OPD register.

Deficiency No. III remark:

Remarks conveyed by MARB to the College:

The Hospital record shows 280-285 patients on all days, which does not seem to correlate with the actual status as seen on the day of visitation.

Submission of College to Commission at appeal stage:

The MARBH Inspection Team visited the hospital premises on 28.08.2023 at 10.45 am at that time 39 OPD patients were Dispensed after examination. Sir Our hospital OPD run for 07 hours every day and hospital record shows daily average number of patients 280-285. Patient Consulted to hospital according to availability and schedule time of Homoeopathic Consultant. Throughout a day inspection Committee is available in college building for observation, so it can be misplaced by them rush of patients because hospital & College Building a different. On that day total number of OPD patients were 277.

It is observed that on 28.08.2023, page number 2369 of annexure E (2) after serial number 5599 the number 6000 appears, but total patients registered was 280 and on 29.08.2023 286 patients were registered.

Deficiency No. IV remark:

Remarks conveyed by MARB to the College:

While asking about the case paper of last three months, college produce only 35 to 40 case paper (June, July and August 2023). Inspection team was not able to correlate the patient details with case papers.

Submission of College to Commission at appeal stage:

On the day of inspection as per demand by inspectors who are observing physically, as they got WhatsApp message from Dr. Neha (Virtual Inspector) to produce and send 5 papers of each OPD & IPD of last 3 months (June, July & August 2023) total 30 case papers (OPD 15 & IPD 15) to MARBH and Virtual Inspector's by mail. After producing these papers, the inspector were satisfied.

Observation of Commission:

The submitted case papers of last 3 months are correlating with the OPD & IPD central register.

Deficiency No. V remark:

Remarks conveyed by MARB to the College:

The registers like central OPD register, department OPD register had entries in a very much escalated list from the actual situation as per the opinion of the inspection team and the genuine functionality of Homoeopathic Hospital is doubtful.

Submission of College to Commission at appeal stage:

Our hospital OPD run 07 hours every day and hospital record shows daily average number of patients 280-285. All record is maintained regularly in software as well as manual registers. (Central OPD, Central IPD, departmental OPD & IPD recorded in software) with genuine presence of Homoeopathic patients.

Observation of Commission:

The college has submitted manual OPD register and on random verification it shows 280 & 286 patients registered on 28.08.2023 & 29.08.2023.

Deficiency No. VI remark:

Remarks conveyed by MARB to the College:

Clinical pathology lab register verified from 31/07/2023 to 19/08/2023. Majority of patient details entered in this date shows investigations like HB, CBC. Similar investigations were seen last one month.

Submission of College to Commission at appeal stage:

Our Hospital is having working Pathology Lab with MICROSCOPE LABOMED, BIOCHEMISTRY AUTOANALYZAR AND TRANSASIA CELL COUNT AND OTHER essential equipment's. It is true that, as on mentioned date majority of patients were advised for common test HB & CBC Investigations accordingly their clinical status and condition but apart from this, with

HB & CBC we are conducting investigation like Urine Routine, RA Factor, BSL, UPT, ESR etc. As per the need and clinical condition of patient.

In Support of this submission, we have submitting herewith.

Observation of Commission:

The college has provided bill invoice dated 17.10.2019 from Aditi Enterprises which shows purchase of mentioned instruments.

Further, from the submitted documents it is also observed that other than HB & CBC other investigations such as x-ray, USG, UPT, Pap-smear, stool/urine test, Blood sugar and mammography are also advised. However, reports are not attached with OPD case records.

While correlating with OPD register, diagnosis like Rheumatoid arthritis, Hypertension, Allergic rhinitis mentioned. Inspection team was not able to correlate with diagnosis related investigations in laboratory register.

Submission of College to Commission at appeal stage:

Correlation of OPD Register with Diagnosis of patients and Lab Investigations. In some cases not possible as it is very subjective to carry out investigations of patients by Homoeopathic Physician. Many patients do their investigations outside hospital lab, which were not attached to case papers. Hospital have many cases which had been already diagnosed outside. So it is very subjective and not objective to correlate diagnosis only on the basis of investigations.

Please refer with 2nd Point of Annexure-D.

Observation of Commission:

Diagnosis is mentioned in the OPD register and investigations are also advised which is correlating the diagnosis. However, the submission is acceptable as hospital cannot bound patients to carry out the investigation in the hospital.

Deficiency No. VIII remark:

Remarks conveyed by MARB to the College:

Allopathic medicines were found inside of patient's bed. Homoeopathic dispensary was not available in IPD.

Submission of College to Commission at appeal stage:

Sir, In our hospital We neither prescribe nor dispense modern medicines to homoeopathic patients are not prescribing Modern Medication to Homoeopathic Patients. We are prescribing ONLY Homoeopathic Medicine. On the day of Inspection allopathic medicines available inside patients' bed were not dispensed by Homoeopathic Physician of our Hospital. Patient brought with him only to show the Homoeopathic consultant.

*We have separate two dispensing unit in hospital one for OPD & Other for IPD. In Support of this submission, we have submitting herewith Homoeopathic Medicine Dispensing Register of Month June, July, August 2023, Geo tag photo of OPD & IPD dispensing mark as per **Annexure-G***

Observation of Commission:

The submission is acceptable, moreover, add on Homoeopathic medicines are acceptable along with allopathic medicines which cannot be withdrawn.

We have functional facility of Operation Theatre, Labour, Delivery & C-section with some critically ill patients, as per CCH MSR-2013, For exposure of students in clinical field and understand the depth of operative surgery and operative Gynaecology and Obstetrics as well as management in critical illness in own or attached hospital. These patients which are examined and treated by modern medicine consultant, So IPD dispensing unit have to maintain anaesthesia drugs, emergency drug, operation theatre products etc.

Observation of Commission:

The college has provided Delivery register, Birth & Death register, OT register which shows proper functioning and as per the available MoU functioning of Dialysis Unit is approved in IPD Block.

Deficiency No. X remark:

Remarks conveyed by MARB to the College:

Inspection team could not accept the functionality of Homoeopathic IPD. Without genuine functionality of Homoeopathic IPD, internship training and PG house-job is doubtful.

Submission of College to Commission at appeal stage:

*As we have functionally Homoeopathic Hospital according to CCH MSR-2013. And all working doctors are of homoeopathic faculty and appointed as per eligibility criteria as per CCH MSR 2013. We have genuine Homoeopathic OPD & IPD which imparting internship training with full involvement of PG Student in their house job duty's. Internship Training Programme is scheduled each batch as per MSR & Rules of affiliated university for UG & PG Students. On the day of Inspection, Hospital Superintendent produced and explained all details regarding internship programme. After verification of produced record inspectors were satisfied. In Support of this submission, we have submitting herewith Biometric attendance of PG House job and internship rotation proforma of Last 3 months mark as per **Annexure-I***

Case history not mentioned clearly in IPD case records. No analysis and evaluation written in IPD case records.

Submission of College to Commission at appeal stage:

Detailed History of Patients in IPD Case record with evaluation and totality of symptoms present in IPD Case records.

Observation of Commission:

The submitted document of IPD case sheets have Analysis and Evaluation of symptoms.

Deficiency No. XII remark:

Remarks conveyed by MARB to the College:

No reportorial chart and repertorisation were found in case records. Chronic case records were without analysis, evaluation and miasmatic diagnosis.

Submission of College to Commission at appeal stage:

*Reportorial chart with repertorisation is available as per the requirement in most of the chronic case records as mentioned above in point number k. We have maintained and produced Totality, analysis, evaluation with clinical diagnosis in case papers of Admitted Patients on the day of Inspection 28.08.2023. **Referral as per Annexure-J**.*

Observation of Commission:

The submitted document have reportorial chart with repertorisation but no miasmatic diagnosis. It is also observed that section of Miasmatic Diagnosis is not available in the case taking proforma.

Deficiency No. XIII remark:

Remarks conveyed by MARB to the College:

IPD case records and functioning of IPD is essential for the internship training. Without proper maintaining of case records patients care and internship training and house job is not possible.

Submission of College to Commission at appeal stage:

College planned & scheduled internship training programme for each batch. College was implemented standard internship programme from 2006 and as per the requirement it was upgraded regularly according to direction of affiliated university, as per MSR published by CCH & NCH. All record of Internship programmes & House

Deficiency No. XIV remark:

Remarks conveyed by MARB to the College:

On examination of OPD case records shows patient demographics not being recorded. All relevant details regarding case history not being mentioned in OPD case records.
